The Kendriya Vidyalaya Sangathan, a centrally funded Autonomous Body, is a Society registered under Societies' Registration Act, 1860. The Sangathan administers the Scheme of Kendriya Vidyalayas set up for imparting education to the children of transferable Central Govt. Employees.

Sealed competitive quotations from the Registered Firms are invited by the undersigned on behalf of the Kendriya Vidyalaya Sangathan for supply of the following items:

3. Bid Price

- a. The contract shall be for the supply of the mentioned items to the KVS. The bidder shall quote for items in the format of quotation attached. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting;
- b. All duties, taxes and other levies payable by the bidder shall be included in the total price. However, the tax and duties leviable should be quoted separately.
- c. The rates quoted by the bidder shall be fixed for the duration of the contract (and shall be quoted in Indian Rupees only);
- d. The prices should be quoted in Indian Rupees only,
- e. Each bidder shall submit only one quotation;
- f. Telex or Facsimile quotations are not acceptable
- *g. The bid should be submitted along with EMD of Rs 2000/- by bank draft in favour of VV N A/c payable at Dwarka.
- h. The firm should enclose supporting documents regarding registration of VAT/ST/ITPAN.

4. Validity of quotations

The quotation shall remain valid for a period not less than 90 days after the deadline specified for submission of quotations.

5. Evaluation of quotations:

The Purchaser will evaluate and compare the quotations determined to be substantially responsive, i.e., which are:

- a) properly signed, and
- b) conform to the terms and conditions and specifications.

The evaluation would be done for all the items put together. The items for which no rates have been quoted would be treated as zero and the total amount would be computed accordingly. The bidder who has quoted for partial quantity of any one or more item(s) would be treated as non-responsive. Purchaser will award the contract to the responsive bidder whose total cost for all the items put together is the lowest.

6. Award of contract:

- (a) The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as per para 5 above;
- (b) The bidder whose bid is accepted will be notified of the award of the contract by the Office prior to expiration of the quotation validity period;
- (c) The Notification of Award to clearly specify any change in the unit price or any other terms and conditions accepted.
- (d) Normal commercial warranty/guarantee shall be applicable to the supplied goods;
***May be struck off in case of Registered Bidders.**
- (e) Payment shall be made within 30 days after the delivery of goods and their acceptance;
- (f) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- (g) **The successful bidder has to deposit performance security with the Kendriya Vidyalaya Dwarka of the amount of 10% order cost in favour of "Vidyalaya Vikas Nidhi" payable at Dwarka in the form of DD/Cash. it will be deducted from your bill no int. will be paid for the same by the vidyalaya. the performance security will be returned only after satisfactory installation and working certificate by the concerned committee.**
- (h) payment of the bill will be paid only after satisfactory installation and demonstration before the committee members.

7. Last date and time of receipt of quotations:

You are requested to submit the sealed quotations in the Tender Box { in front of Room No. } super scribed on the envelope as "*Quotations for the supply of Furniture*", for the due on latest by 01.04.2018 by 10.30 am. The quotations shall be opened at 1.00pm on the same day. The bidders or their representatives who choose to be present at the time of opening of quotation are invited to do so.
